# **DIRECTIONS FOR USE**

FUEL PRESERVATION: KATHON™ FP BIOCIDE is recommended for the control of bacteria and fungi in the following liquid hydrocarbon fuels and oils: liquefied petroleum gases, aviation fuels, petrochemical feedstocks, kerosene, heating oils, diesel fuels, residual fuel oils and coal slurries.

METHOD OF ADDITION: Add KATHON<sup>TM</sup> FP BIOCIDE at 8 kilos to 24 kilos per one million kilos of total system (fuel and water) depending on degree of fouled system. This will provide 1.5 to 4.5 ppm active ingredient.

KATHON<sup>™</sup> FP BIOCIDE weighs 1.25 KG/L.
