DIRECTIONS FOR USE:

1. Pull tab back to open.
2. Remove towelette from pouch. Reseal firmly.
3. Wipe towelette evenly over all exposed skin except eyes and mouth. Apply sparingly not under clothing and only when necessary. Each towelette will cover an adult face and arms, or an equivalent area.
4. In order to guarantee freshness of towelettes, do not place used towelette back into pouch. After using, dispose of used towelette in garbage.
5. Reapply after 6 hours if necessary.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. DO NOT USE ON CHILDREN UNDER 12 YEARS OF AGE. Avoid contact with eyes and mouth, rayon, dnyel, acetate or plants. May damage furniture finishes, plastics, and painted surfaces. Keep away from open

FIRST AID: If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If ingested: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL: Dispose of used towelette in household garbage (also dispose of container when it is empty).
