DIRECTIONS FOR USE:

GENERAL: SHAKE BEFORE USE. HOLD CONTAINER UPRIGHT. APPLY IN SHORT BURSTS. Use EVERCIDE Crawling Insect Spray as a spot or crack and crevice treatment to control cockroaches, silverfish, ticks, fleas and other insects listed below. Apply this product only as a coarse spray or crack and crevice treatment to localised areas where pests are found or may occur. Spray surfaces until wet. Repeat as needed.

FOR SPOT TREATMENT:

<u>To Kill Ants, Cockroaches, Crickets, Silverfish, Spiders, Sowbugs, Earwigs, and Carpet Beetles</u>: Spray areas where these pests are found or may hide, including dark corners of rooms and closets; cracks and crevices in walls; along baseboards and door and window frames; behind and beneath sinks, stoves, refrigerators, and cabinets and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. For ants, apply to ant trails, also around doors and windows and wherever else these pests may find entrance. Repeat as necessary.

<u>To Kill Brown Dog Ticks and Fleas</u>: Thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localised areas of floor and floor coverings where these pests may be present. Old bedding should be removed and replaced with clean, fresh bedding after treatment.

<u>Do Not Treat Pets With This Product</u>. For effective flea and tick control, pets should be treated with a registered flea and tick control product designed for use on pets (N.B. this product is not for use on pets), and treatment of the pet must be combined with the cleanup and sanitation of any area used by the pet. <u>Flies and Mosquitoes</u>: Use only out of doors as an aid in reducing annoyance from these insects.
