When applied directly, crawling insects are usually killed within 48 hours from cutting action. Product is effective as long as it is present. This odourless fine powder will not stain and can be used safely when used according to the label directions.

DIRECTIONS:

Application rate: Lightly coat desired areas using 50 g of this product per 10 m².

Outdoor use: For best results use in areas where dust application cannot be affected by heavy rains or high winds. Lightly coat areas where ants are seen or may hide, including around building foundations, window and door sills, patios, porches, along ant trails, around gardens, and under hedges, shrubs and trees. Do not apply to food crops.

Indoor use: Lightly coat areas where ants are seen or may hide, such as cracks, crevices, behind and beneath appliances, cabinets, sinks, garbage cans, pipe and drain openings, attics and basements.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid breathing dust. Do not use as a space spray. Avoid contact with eyes.

FIRST AID: **If in eyes,** hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If inhaled,** move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.
