DIRECTIONS FOR USE

THIS PRODUCT IS TO BE USED ONLY AS AN ANTIMICROBIAL.

FOR THE PRESERVATION OF CLAY SLURRIES, ADHESIVES, AND HIGH VISCOSITY SUSPENSIONS:

For preservation of slurries and high viscosity suspensions, AMA-35D-PC should be added at a point in the processing system where there will be sufficient time and agitation for good mixing and dispersion. Add AMA-35D-PC at use levels of 0.04-0.11% by weight, based on the total formulation in slurries of starch, clay, calcium carbonate or titanium dioxide; high viscosity suspensions (e.g., polymers; silica-polymer combinations); polyvinyl alcohol/polyvinyl acetate-based adhesives; starch-based adhesives; dextrin-based adhesives. The exact amount of material to be added for the preservation of any given formulation will depend on the components and local storage conditions. Dosage rates should be determined by actual tests. Products containing this antimicrobial pesticide are not to be used in food packaging materials or food contact products.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

As this product is not registered for the control of pests in aquatic systems, DO NOT use to control aquatic pests.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN

WARNING!

Fatal or Poisonous if swallowed or absorbed through the skin. DO NOT get on skin or on clothing. Harmful if inhaled. Avoid inhaling/breathing vapor or sprays. CORROSIVE to the eye and to skin. DO NOT get in eyes or on skin. Potential skin sensitizer.

USE WITH ADEQUATE VENTILATION. KEEP CONTAINER CLOSED. AVOID CONTAMINATION OF FOOD

Wear chemical-resistant coveralls over a long-sleeved shirt, long pants, chemical-resistant gloves, socks and chemical-resistant footwear, eye protection (goggles or a faceshield) and a respirator with a NIOSH-approved organic-vapour-removing cartridge with a prefilter approved for pesticides, or a NIOSH-approved canister approved for pesticides during mixing, loading, clean-up and repair.

Avoid touching eyes and face until you have washed your hands. Repair/replace torn or broken personal protective equipment.

Use hot water, heavy-duty liquid detergent, the highest water level setting, and the longest wash cycle. Keep and wash personal protective equipment separately from other laundry.

If heavily soiled, wash personal protective equipment two or three times. After washing, run the washing machine through a complete cycle with detergent. If possible, line-dry the clothing.

Discard clothing that has heavily contaminated with this product. Do not reuse.

FIRST AID:

In case of contact with eyes, hold eye open and rinse slowly and gently with water for 15– 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control center or doctor for treatment advice.

If swallowed, call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

TOXICOLOGICAL INFORMATION: There is no specific antidote. Medical personnel should provide symptomatic or supportive treatment. Probable mucosal damage may contraindicate the use of gastric lavage.

STORAGE
