DIRECTIONS FOR USE

This product may be used to formulate products for the following uses: all residential indoor, food, non-food, and institutional use areas.

To be used only in the manufacture of insecticides which are registered under the Pest Control Products Act. This product is to be used with appropriate solvents and carriers, and in the case of pressurized products, propellants, to produce an insecticide product.

Mix well in drum before sampling and each use.

**PRECAUTIONS:** KEEP OUT OF REACH OF UNAUTHORISED PERSONNEL. May be fatal if swallowed, inhaled, or absorbed through the skin. Do not breathe vapors. Causes skin irritation. Do not get in eyes, on skin or on clothing. Wash thoroughly with soap and warm water before eating or smoking. Wash all contaminated clothing with soap and water before reuse. Continued exposure to this product will increase susceptibility to it and other cholinesterase inhibitors. Wear natural rubber gloves, protective clothing and goggles when working with this material. Wear an approved respirator. Keep all unprotected persons out of operational areas. Do not contaminate food or feedstuffs. This product is toxic to fish. Do not apply directly to any body of water by cleaning of equipment or disposal of wastes. Do not use or store near heat or open flame.

**FIRST AID:** In case of contact with eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. In case of contact with skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not give any liquid to the person. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** This product contains cholinesterase inhibitor. Atropine, by injection, is antidotal and should be administered only if signs of cholinesterase inhibition have appeared. 2-PAM is also antidotal and may be used in conjunction with atropine. This product contains petroleum distillate. Vomiting may cause aspiration pneumonia.

**STORAGE:** Keep in original container during storage. Store product in cool, dry, well ventilated place away from seed, fertilizer, or other pesticides. Keep away from fire or open flame, or other source of heat.

**DECONTAMINATION AND DISPOSAL:** Canadian formulators using this product should dispose of unwanted active ingredient and containers in accordance with municipal or provincial regulations. For additional details and cleanup of spills, contact the provincial regulatory agency or the manufacturer.
