DIRECTIONS FOR USE:

To be used only in the manufacture of a herbicide which is registered for use under the Pest Control Products Act.

PRECAUTIONS Hazards to Humans and Domestic Animals.

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Harmful if swallowed. May cause eye irritation. Avoid contact with skin, eyes or clothing. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse. Harmful if inhaled. Avoid breathing dust. Use with adequate ventilation. For mixing and loading, wear cotton coveralls and chemical-resistant gloves.

FIRST AID

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION

Overexposure to chlorpropham may result in methemoglobinemia. Treat symptomatically.

PHYSICAL OR CHEMICAL HAZARDS:

Do not use or store near heat or open flame.

ENVIRONMENTAL HAZARDS:

Do not contaminate water by cleaning of equipment or disposal of wastes. This product is toxic to fish. Keep out of lakes, ponds or streams.

STORAGE:

Keep in original container during storage. Store product in cool, dry, well-ventilated place away from seed, feed, fertilizer, or other pesticides. Keep away from fire or open flame, or other sources of heat.
