For use as a spot or crack and crevice treatment to control insects listed on front panel.

DIRECTIONS: SHAKE CAN WELL BEFORE USING. Hold container approximately 30 cm from surface being sprayed and spray until wet. Thorough applications produce a coating which will vaporize into cracks and crevices for insect control. If reinfestation occurs, repeat applications as necessary. Provide adequate ventilation after indoor use. **KEEP PETS AND CHILDREN AWAY FROM SURFACE UNTIL DRY.**

INDOOR USE: Thoroughly treat cracks, crevices and spots along and behind baseboards, underneath furniture and equipment, around garbage containers, localized areas of floors and floor coverings and other places where insects hide or are seen.

OUTDOOR USE: Spot Treatment: Spray outside surfaces of screens, doors, window frames, foundations, patios, light fixtures and other places where insects may alight, or congregate and enter.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed, inhaled or absorbed through skin. TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL: When container is empty, press button to release all pressure, then dispose in household garbage. Do not puncture or incinerate.
