DIRECTIONS FOR USE: To be used only in the manufacture of a wood preservative which is registered under the PEST CONTROL PRODUCTS ACT.

FIRST AID: IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. **IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. **IF INHALED:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. **IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat for arsenic poisoning. If swallowed, give 30 mL of milk of magnesia or aluminum hydroxide gel suspended in water (the whites of two or three eggs may be used.) Follow with an emetic (15 mL of mustard or table salt in a glass of warm water.). Then give olive oil or mucilaginous drink.

PRECAUTIONS: PREVENT ACCES BY UNAUTHORIZED PERSONNEL. FATAL IF SWALLOWED, ABSORBED THROUGH SKIN OR INHALED. CORROSIVE. CAUSES IRREVERSIBLE EYE DAMAGE AND SKIN BURNS. Do not get in eyes, on skin, or on clothing. Do not breathe

dust or spray mist. Wear face shield, plastic gown with long sleeves and gloves when handling. Wear a mask or pesticide air purifying respirator equipped with a high efficiency filter jointly approved by the Mining Enforcement and Safety Administration, and the National Institute for Occupational Safety and Health. Wash thoroughly with soap and water after handling and before eating or smoking. Remove contaminated clothing and wash before reuse. Provide adequate ventilation. Keep container closed and away from combustible materials. Cancer hazard - Can Cause Cancer!

STORAGE: ARSENIC ACID 75% should not be stored in tightly sealed, unlined metal containers (other than stainless steel) because of the possibility of excessive pressure developing from hydrogen liberation. Keep closures up to prevent leakage. Do not store in a manner where crosscontamination with other chemicals, food, or feed could occur.
