**DIRECTIONS FOR USE:** Repels mosquitoes for 5 hours. Also repels black flies, biting midges, deer flies, stable flies, ticks and chiggers. Apply sparingly not under clothing and only when necessary. Reapply after 5 hours if necessary. Hold container upright and spray clothing and exposed skin except face. **TO APPLY TO FACE:** Spray hands and apply avoiding eyes and mouth. Do not spray in enclosed spaces.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. CONTENTS UNDER PRESSURE. Do not place in hot water or near radiators, stoves or other sources of heat. Do not puncture or incinerate container or store at temperatures over 50°C. Do not spray near open flame or spark, or while smoking. Do not contaminate food, utensils or any body of water. Avoid contact with eyes and mouth. Do not use on children under 12 years of age. AVOID contact with plastic and fabrics such as acetate, rayon and dynel. May damage furniture finish, plastics and painted surfaces.

**FIRST AID:** If irritation or other adverse skin effects develop, wash affected area with soap and water immediately. Seek medical attention if symptoms persist. **If in eyes:** remove contact lenses, and flush eyes with water for 15 minutes. **If inhaled:** if person is not breathing, give artificial respiration. **If swallowed:** DO NOT induce vomiting. DO NOT give any liquid. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
