**DIRECTIONS FOR USE:** To control insects listed on front panel, apply to cracks, crevices or as a spot treatment.

SHAKE CONTAINER WELL. Insert the plastic tube into nozzle before applying product. The nozzle and formula of this product are designed to produce a foam for better penetration of cracks, crevices, or tight areas that are difficult to reach. The product penetrates cracks and crevices and then expands leaving an insecticidally active residue. Spray directly into cracks and crevices particularly under baseboards where cockroaches like to hide, and where the insecticide won't be mopped away. Spray into hard to reach places, behind refrigerators, washers, under sinks, between cabinets and under counters. KEEP PETS AND CHILDREN AWAY UNTIL RESIDUE IS DRY.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not place in hot water or near radiators, stove or other sources of heat, or store at temperatures over 50°C. Harmful if swallowed, inhaled or absorbed through skin. May cause eye or skin irritation. Avoid contact with eyes, skin, or clothing. DO NOT USE ON HUMANS, PLANTS, ANIMALS, FOODSTUFFS, FOOD UTENSILS, FISHBOWLS OR ANIMAL FEED AREAS. DO NOT USE AS A SPACE SPRAY. DO NOT CONTAMINATE FOODSTUFFS. If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

**DISPOSAL:** When container is empty, press button to release all pressure, then dispose with household garbage. Do not puncture or incinerate.
