## NOTICE TO USER

## FIRST AID

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**If swallowed**, call a poison control centre or doctor immediately for treatment advice. Have a person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**For eyes**, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Perform gastric lavage taking care to prevent aspiration of gastric contents. Then treat symptomatically.

## PRECAUTIONS

Avoid drift onto other plants.

Use only as directed on the label. Store away from food or access by children or pets.

## STORAGE

Store product in a cool, dry, well ventilated area away from food and feed, and out of reach of children and animals. Keep product from freezing.

## SPILL CLEANUP

Do not re-use soil contaminated by BONZI Plant Growth Regulator. Wear appropriate protective equipment (gloves, glasses, apron) when attempting to clean up the spill. If the container is leaking, secure leak and place the container into a drum or heavy gauge plastic bag. Contact Syngenta Canada, Inc. (See EMERGENCY NUMBER) for further information.

For spills and leaks; contain the liquid with dikes of inert material (soil, clay, kitty litter etc.). Absorb the spill onto inert material and shovel into a sealable waste container.

On hard surfaces - sprinkle spill area with detergent and scrub in a small quantity of water with a coarse broom. Let stand for 10 minutes then absorb onto an inert material and shovel waste into a waste container.

On soil - remove the top 15 cm of soil in the spill area and replace with fresh soil. Dispose of all waste including scrub brush in accordance with provincial requirements. For more information on the disposal of waste and the clean up of spills, contact the Provincial Regulatory Agency or the manufacturer.

## DISPOSAL AND DECONTAMINATION

Canadian formulators of this technical should dispose of unwanted active ingredient and containers in accordance with municipal or provincial regulations. For information of disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency.
