## **DIRECTIONS:**

**Later's Sevin<sup>®</sup> Liquid** is effective for the control of many insects on Lawns, Ornamental Plants, Vegetables and Fruits when used as directed. Apply when insects or damage appears. Spray in early morning or late evening to avoid injury to bees and to crops from spraying during high temperature. Spray to point of run-off, monitor insect activity and repeat applications at 7-10 day intervals if necessary.

## **SPRAY PREPARATION:**

**Later's Sevin<sup>®</sup> Liquid** readily disperses in water to form a spray suspension suitable for home and garden use. Shake container thoroughly before using. Prepare only as much spray mixture as is needed on the day of application. Shake spray mixture frequently before and during use to prevent settling. Do not store spray mixture overnight.

5 mL = 1 teaspoonful	15 mL = 1 tablespoon
1 L = approx. 1 quart	10 m <sup>2</sup> = approx. 100 sq. ft.

## **HOW TO USE:**

### **On Fruit:**

Mix 5 mL of **Sevin<sup>®</sup> Liquid** with 1 L of water (or 5 teaspoons / 1 gal.). Apply for thorough coverage to the point of run-off. Do not spray within 7 days of harvest.

Use on: Apples, Apricots, Cherries, Peaches, Pears, Plums.

To Control: Aphids, Apple Maggots, Coding Moths, Cherry Fruit Flies, Fruitworms, Leafhoppers, Leafminers, Leafrollers, Mealybugs, Pear Slugs, Scale insect (crawlers), Tent Caterpillars.

### **On Berries & Grapes:**

Mix 8 mL of **Sevin Liquid** with 1 L of water to cover 10 m<sup>2</sup> (or 8 teaspoons / 1 gal./500 sq. ft.). Do not spray within 7 days of harvest.

Use on: Blackberries, Blueberries, Boysenberries, Loganberries, Raspberries, Strawberries and Grapes.

To Control: Climbing Cutworms, Leafhoppers, Leafrollers, Fruitworms, Spittlebugs.

**On Vegetables:**

Do not spray within 7 days of harvest or within 14 days of leafy vegetables.

Use on: Asparagus, Beans, Beets, Broccoli, Brussels Sprouts, Cabbage, Carrots, Cauliflower, Celery, Chinese Cabbage, Corn, Cucumber, Eggplant, Endive, Horseradish, Kale, Kohlrabi, Lettuce, Melons, Parsley, Parsnip, Pepper, Potato, Pumpkin, Radishes, Rutabagas, Spinach, Squash, Swiss Chard, Tomato, Turnip, Watercress.

To Control: Asparagus, Beetles, Fleabeetles, Leafhoppers, Mexican Bean Beetles, Colorado Potato Beetles, Corn Earworms, Corn Borers, Cucumber Beetles, Squash Bugs.

Mix 5 mL of **Sevin Liquid** with 1 L of water to cover 10 m<sup>2</sup> (or 5 teaspoons/1 gal./500 sq. ft.)

To Control: Armyworms, Fruitworms, Tomato Hornworms, Stinkbugs, mix 7 mL of **Sevin<sup>®</sup> Liquid** with 1 L of water to cover 10 m<sup>2</sup> (or 7 teaspoons/1 gal./500 sq. ft.).

To Control: Climbing Cutworms, mix 10 mL of **Sevin<sup>®</sup> Liquid** with 1 L of water to cover 10 m<sup>2</sup> (or 10 teaspoons/1 gal./500 sq. ft.).

**On Ornamentals:**

Mix 5 mL of **Sevin<sup>®</sup> Liquid** with 1 L of water (or 5 teaspoons/1 gal.). Apply for thorough coverage to the point of run-off.

Use on: Arborvitae, Azalea, Birch, Boxwood, Carnation, Chrysanthemum, Dogwood, Elm, Gladiolus, Holly, Hydrangea, Juniper, Lilac, Maple, Oak, Pines, Rose, Zinnia.

To control: Rose Aphids, Bagworms, Birch Leafminers, Black Vine Weevils, Blister Beetles, Boxelder Bugs, Boxwood Leafminers, Cankerworms, Elm Leaf Beetles, Flea Beetles, Gypsy Moths, Japanese Beetles, June Beetles, Lace Bugs, Leaf Hoppers, Leaf Rollers, Mealybugs, Pine Saw Flies, Plant Bugs, Psyllids, Rose Chafer, Rose Slugs, Scale Insects (crawlers), Spruce Budworms, Tent Caterpillars, Thrips (exposed), Willow Leaf Beetles.

Note: Do not use on Boston Ivy, Virginia Creeper and Maidenhair Ferns. During early season, it may also injure Virginia and sand Pines. For Scale Insects, apply when crawlers are present.

**On Lawns:**

To Control: Ants, Chinch Bugs, Earwigs, Fall Armyworms, Fleas, Leaf Hoppers, Millipedes, Mosquitoes, Sod Webworms.

Mow lawn and apply at the rate of 50 mL of **Sevin<sup>®</sup> Liquid** with 20 L of water to cover 10 m<sup>2</sup> of area (or 4 tablespoons/4 gal./100 sq. ft.). Do not water for 2 days after treatment. Repeat application in 2-3 weeks if necessary.
