For clear pool water, follow our 3 step pool care program:

Step 1: Chlorinate Step 2: Shock Treat

Step 3: Prevent Algae

Note: It is recommended that water be balanced before following this 3-step process.

DIRECTIONS FOR USE

1 Initial treatment for prevention of algae growth in clear pool water: Use 62 to 94 mL of **ALGIMYCIN® 2000** for every 10,000 liters of water.

2 Initial treatment for pools with visible established algae: Use 125 to 188 mL of **ALGIMYCIN 2000** for every 10,000 liters of water weekly.

3 Blue-green algae control: Apply 125 mL of **ALGIMYCIN 2000** for every 10,000 liters of water when algae first appears. Brush algae daily to remove dead algae. Vacuum out settled out algae.

4 To maintain pool free of visible algae growth: Use 31 to 62 mL of **ALGIMYCIN 2000** for every 10,000 liters of water.

5 To winterize: Use 125 mL of **ALGIMYCIN 2000** per 10,000 liters. For no cover, or if a mesh cover is used, a second application may be needed midway through the season.

METHOD OF APPLICATION

- 1 SHAKE WELL before measuring out required amount.
- 2 Distribute the product uniformly throughout the pool water.

Call a poison control centre or doctor for treatment advice. **If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

STORAGE: Do not store below 0°C.
