**DIRECTIONS FOR USE:** To be used in the manufacture of a herbicide which is registered under the PEST CONTROL PRODUCTS ACT.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN AND UNAUTHORIZED PERSONNEL. Avoid contact with eyes, skin and clothing. Harmful if swallowed. May cause eye or skin irritation. Do not inhale vapors. Wash well after handling and before eating, drinking and smoking. Wash contaminated clothing with soap and hot water before reuse. Do not wear contaminated shoes.

**ENVIRONMENTAL PRECAUTIONS:** TOXIC to aquatic organisms and non-target terrestrial plants. This product contains a petroleum distillate which is moderately to highly toxic to aquatic organisms. Avoid contamination of aquatic systems. Do not contaminate irrigation water, lakes, streams or ponds by cleaning of equipment or disposal of wastes.

**FIRST AID:** Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**Ingestion:** If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

**Eye Contact:** If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**Skin or Clothing Contact:** If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**Inhalation:** If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for treatment advice.

**STORAGE:** Keep in original container during storage. Store product in cool, dry, well ventilated place away from seed, feed, fertilizer, or other pesticides. Keep away from fire, open flame or other sources of heat.

**DISPOSAL:** Canadian formulators of this manufacturing product should dispose of unwanted active ingredient and containers in accordance with municipal or provincial regulations. For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. **SPILLAGE CLEAN-UP:** Keep by-standers away. Do not smoke, drink or eat during clean-up operations. Wear protective equipment (respirator, coveralls, rubber boots and protective gloves) and sweep up all product and shovel into a drum. Cover remaining spill with absorbent material and sweep into drum. Add broken packages to the drum and seal for removal to an approved disposal site. Wash spill site with water and mop up into a drum for disposal to an approved disposal site. Do not breathe vapours. Remove and wash all protective clothing and equipment.
