NYLAR[®] Pressurized Spray 2618 kills fleas. It contains a combination of ingredients that kills both adult and preadult fleas. NYLAR[®], a unique ingredient in this flea spray, prevents adult fleas (biting stage) from emerging for 150 days (5 months) by preventing the immature flea from developing into the adult biting stage. Effective on fleas hidden in carpets, rugs, drapes, upholstery, and pet bedding. Protects your home from flea buildup. One treatment with this spray continuously prevents the emergence of adult fleas for 150 days. Leaves no objectionable odor or sticky mess and if used as directed, does not stain furnishings. Note: The degree of control may be reduced by heavy use after treatment, vacuuming, or shampooing of the carpet.

DIRECTIONS FOR USE: Use only for spot treatment, or to treat pet bedding. Application to upholstered furniture must be limited to tufts and seams only. Be sure to treat pet bedding as well as pet resting surfaces of upholstered furniture as this is a primary hiding place for fleas. Vacuum floors, carpets, and furniture (discard vacuum bag after use) and wash the pet's bedding, living quarters, and surrounding areas prior to treatment with this product. **DO NOT** apply as a broadcast application or as a space spray. **DO NOT** apply to mattresses, linens, toys or clothing. **DO NOT** apply to overhead areas or in confined spaces (for example, attics and crawlspaces). **DO NOT** use NYLAR[®] Pressurized Spray 2618 in food handling, storage, or preparation areas while food is present. **DO NOT** allow spray to drip or allow drift onto non-target surfaces; any spray residue on non-target areas must be removed by the applicator. Avoid treating recommended sites/surfaces until wet. SHAKE WELL before use.

For application to pet bedding: Hold can 60 to 90 centimeters from pet bed surface to be treated. Spray up to one square meter in approximately 35 seconds. Be sure to apply uniformly using a sweeping motion. No need to remove pet bedding after treatment.

- **DO NOT** allow people to sleep or play on pet bedding after it has been treated. **DO NOT** allow people or pets to contact treated areas until sprays have dried.
- **DO NOT** spray on bedding of pets which are less than 8 weeks of age.
- **DO NOT TREAT PETS WITH THIS PRODUCT.** For effective flea control, pets should be treated with a registered flea control product designed for use on pets, and treatment of the pet should be combined with the sanitation of any area used by the pet.

For application to indoor surfaces such as carpets, rugs and drapes and including pet resting surfaces: apply ONLY as a spot application. Spot application is localized to a surface area not more than 0.2 m². Spots are not to be adjoining. The combined area of spots is not to exceed 10% of the total surface area of a room. Hold can 60 to 90 centimeters from surface to be treated. Spray a maximum area of 0.2 m² in approximately 7 seconds.

For application to upholstery, including pet resting surfaces: apply ONLY to tufts and seams. Tufts and seam treatment is considered to be an application to the junction of two or more pieces of fabric and any decorative trim (for example, buttons). Hold can 60 to 90 centimeters from surface to be treated. Spray a maximum area of 0.2 m² in approximately 7 seconds. For decorative trim measuring approximately 12 cm x 12 cm, spray in a single short burst of a maximum of 0.5 seconds.

PRECAUTIONS: Keep out of reach of children and pets. Harmful if swallowed or absorbed through skin. **DO NOT** breathe vapors or spray mist. Avoid contact with skin or eyes. Avoid contamination of food and feedstuffs. **DO NOT** use in food processing or preparation areas. **DO NOT** apply to surfaces that may come into contact with food/feed. Cover or remove all food/feed. Cover all food/feed processing surfaces, equipment and utensils or thoroughly wash following treatment. Remove all pets and birds and cover fish aquariums before spraying. **DO NOT** apply when people or pets are present. **DO NOT** allow people or pets to enter/contact treated areas until sprays have dried. Ventilate treated areas after application by opening windows and doors or using fans where required to aid in the circulation of air. Wash with soap and warm water after use. Wash contaminated clothing with warm water and soap before reuse.

Contents under pressure. Keep away from heat, sparks and open flame. Do not puncture or incinerate container. Exposure to temperatures above 50°C may cause bursting.

FIRST AID: **If in eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. **If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically. This product contains a petroleum distillate. Vomiting may cause aspiration pneumonia.

ENVIRONMENTAL HAZARDS: Toxic to aquatic organisms.

STORAGE: Store in a cool, dry place inaccessible to children. Keep container closed.
