**DIRECTIONS FOR USE:**

Use Area	Reason for Treatment	Concentration	Application techniques
Ceramic	To prevent the decomposition of ceramic glazes and clay slips	0.05-0.1% by weight of glazes or slip formulation	Add to ingredients as they are loaded into ball mill
Polish <sup>1</sup>	For shelf preservation of automotive polishes and polishing compounds	0.25% by weight of polish and 0.25-0.5% of polishing compound	Add to polish or polishing compound during the formulation process
Automotive	To preserve felt gaskets	1% by weight of organic solvent	Saturate felt with a solution of Preventol O Extra Preservative in alcohol, Stoddard Solvent or another appropriate solvent
Paper Dyes	To preserve paper dyes by controlling bacteria and mould	0.1% by weight of the dye	Evenly mix with dispersing agents for processes where the temperature does not exceed 100°C. For all other processes, meter the product directly into the material to be preserved during the cooling step after the temperature falls below 50°C. Stir to mix thoroughly. For aqueous solutions, convert Preventol O Extra Preservative to the Sodium salt with caustic and dilute the solution to the desired strength.
Starch Powder	To preserve starch powders by controlling bacteria and mould	0.0625% by weight of starch powder	Thoroughly mix with the starch powder until the mixture is homogenous
Concrete Additives	To protect concrete additives by controlling mould and yeasts	0.3% by weight of the additive	Add to additive and mix until mixture is homogenous. For aqueous solutions, convert Preventol O Extra Preservative to the Sodium salt with caustic and dilute the solution to the desired strength.

<sup>1</sup> Do not use products containing Preventol O Extra Preservative in food packaging materials or in areas where food is processed.

**PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN.** Harmful if swallowed or inhaled. Corrosive, causes skin and eye irritation. Do not breathe dust.

Wear a long-sleeved shirt, long pants, chemical-resistant gloves, respirator, goggles or face-shield when handling product.

Toxic to fish, do not contaminate any body of water by cleaning equipment or disposing of wastes. Do not store near heat or open flame. Store in a cool dry location.

**FIRST AID:**

**IF SWALLOWED:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

**IF INHALED:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**ENVIRONMENTAL HAZARDS:** This pesticide is toxic to fish. Do not discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters. Open dumping is prohibited.
