DIRECTIONS FOR USE: Use in confined areas such as porches, covered patios and other areas where there is little movement of air. See instructions inside for separating coils. Insert the slot of the coil onto the metal stand provided. Light outer end of coil until sustained glow is obtained, then blow out flame. Place coils as required at 2.5-3 m intervals (1 coil per 30m³ of confined space). Each coil burns for up to 5 hours.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Caution children not to touch lit end. Do not place in direct contact with flammable surfaces. Avoid inhalation of smoke. Do not use in restaurants. Cover exposed food or feed to avoid contamination.

DISPOSAL: Wrap and dispose of empty container and stands in household garbage.

FIRST AID: If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for treatment advice. Take container, label or Pest Control Product Registration Number with you when seeking medical attention.

DIRECTIONS FOR USE:

1. Use in confined areas such as porches, covered patios and other areas where there is little air movement.
2. Place coils as required at 2.5-3 metre intervals (1 coil per 30 m³ of confined space). Each coil burns for up to 5 hours. Each package contains 2 coils. Separate prior to use.
3. Bend the centre of the metal stand to upright position.
4. Insert the slot of the coils into the top of the stand.
5. Light outer end of coil with match.
6. Place coils as required at 2.5 – 3 m intervals (1 coil per 30m³ of confined space).
7. A broken piece may be used by inserting it into the open gap of the metal stand.

PRECAUTIONS:

1. KEEP OUT OF REACH OF CHILDREN.
2. Do not place in direct contact with flammable surface.
3. Avoid prolonged inhalation.
4. Cover exposed food to avoid contamination.
5. Do not touch lit end.
