**DIRECTIONS FOR USE:** Dilution of this product using the Twist 'n Fill™ Chemical Dispenser will result in a minimum of 150 ppm active ingredient in the ready-to-use solution.

**Sanitizing Food Contact and Other Surfaces:** For use on precleaned, hard, non-porous surfaces such as counter tops, eating utensils, and drinking glasses. Rinse the surface to remove food particles and soil. Rinse with potable water prior to application of sanitizing solution. Then use 3M Sanitizer Concentrate (Ready-to-Use) for a minimum contact time of 1 minute in a single application. Can be applied with a mop, sponge, cloth, coarse sprayer, or by soaking. Thoroughly wet all surfaces. Drain thoroughly. Do not rinse. Prepare a fresh solution for each use then discard.

**Restaurant and Bar Use:** For use as a sanitizer on dishes, glassware, silverware, cooking utensils, wash with detergent, rinse thoroughly and immerse in 3M Sanitizer Concentrate (Ready-to Use) for at least 1 minute. Drain thoroughly. Do not rinse. 3M Sanitizer Concentrate is effective against the following organisms according to the AOAC Germicidal & Detergent Sanitizer Test, modified in the presence of 800 ppm water hardness (calculated as CaCO<sub>3</sub>): Staphylococcus aureus, Escherichia coli.
