RECIRCULATING COOLING WATER SYSTEMS: When used as directed, ALG-ERASE effectively controls algal, bacterial and fungal slimes in commercial and industrial cooling towers; influent water systems such as flow through filters, and lagoons; heat exchange water systems, industrial water scrubbing systems; and industrial air washing systems equipped with a mist eliminator.

DOSAGE RATES: Initial Dose. When system is noticeably fouled, add 0.25-0.75 kg/10,000 L of water contained in the system. Repeat initial dosage until at least 1 mg/L bromine residual is established for at least 4 hours.

Subsequent Dose. When microbial control is evident, add 0.1-0.4 kg/10,000 L of water contained in the system. Repeat as needed to maintain at least 1 mg/L bromine residual in the water for at least 4 hours.

FIRST AID:
