DIRECTIONS FOR USE: To be used only in the manufacture of an antimicrobial product which is registered under the PEST CONTROL PRODUCTS ACT.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN AND PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Harmful if swallowed or inhaled. Corrosive; causes skin and eye irritation. Do not breathe dust. Wear a respirator, goggles or face shield and gloves when handling product. Toxic to fish; do not contaminate any body of water by cleaning equipment or disposal of wastes. Do not store near heat or open flame. Store in a cool, dry location.

FIRST AID: If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

STORAGE: Keep in original container during storage. Store product in cool, dry, well ventilated place away from seed, feed, fertilizer or other pesticides. Keep away from fire, open flame or other sources of heat.
