DIRECTIONS FOR USE

POTATO ST 16 should be used only in accordance with recommendations on this label.

POTATOES: Apply 500 g of POTATO ST 16 per 100 kg of poato seed pieces for the control of Fusarium Seed Piece DecayApply thoroughly to coat the surface of whole or cut seed pieces with dust. If treated whole seed is cut, make a second application t o protect the cut surface. Plant as soon as possible after treatment. If cut seed is not planted immediately, store in a well ventilated location to permit cut surface to dry Do not use surplus treated seed pieces for food or feed.

RESISTANCE MANAGEMENT RECOMMENDATIONS

For resistance management, please note that POTATO ST 16 contains a Group M fungicide. Any fungal population may contain individuals naturally resistant to POTATO ST 16 and other Group M fungicides A gradual or total loss of pest control may occurover time if these fungicides are used repeatedly in the same fields. Other resistance mechanisms that are not linked to site of **iact** but specific for individual chemicals, such as enhanced metabolism, may also exist. Appropriate resistance-management strategies should be followed.

To Delay Fungicide Resistance:

- Where possible, rotate the use of POTATO ST 16 or other Group M fungicides with dfferent groups that control the same pathogens.
- Use tank mixtures with a fungicide from a different group when such use is permitted.
- Fungicide use should be based on an IPM program that includes scouting, historical information related to pesticide use and crop rotation and considers cultural, biological and other chemical control practices.
- Monitor treated fungal populations for resistance development.
- If disease continues to progress after treatment with this product, do not increase the use rate. Discontinue use of this phoct and switch to another fungicide with a different target site of action, if available.
- Contact your local extension specialist or certified crop advisors for any additional pesticide resistance management and/or IPM recommendations for specific crops and pathogens.

FIRST AID

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centreor doctor for treatment advice. If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth
