NETREX^(TM) AF

NETREX^(TM) AF is a water soluble impregnation agent to be used in the aquaculture industry to inhibit the attachment and growth of marine organisms on fish nets.

To ensure season long fouling protection, treated fishing nets should be examined at the beginning of each season to determine if re-application is required.

DIRECTIONS FOR USE:

1. Fishing nets should be clean and dry prior to application.
2. Stir vigorously before use.
3. Liberally apply by immersion, and allow nets to soak in NETREX^(TM) AF for minimum 15 minutes.
4. Allow nets to dry for minimum of 24 hours before use. **DO NOT** place treated nets in the bodies of water before they are completely dry.
5. Clean tools, protective gloves and clothing with water when finished.
6. Do not apply at temperatures below +4°C/+39°F.
7. **DO NOT** apply this product in a way that will contact workers or bystanders, either directly or through drift. Only protected handlers may be in the area during application.
8. **DO NOT** contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.
9. **DO NOT** apply this product directly to freshwater habitats (such as lakes, rivers, sloughs, ponds, prairie potholes, creeks, marshes, streams, reservoirs and wetlands), or estuarine/marine habitats.
10. **DO NOT** discharge effluent containing this product or the biocide produced into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters unless the effluent has been detoxified by suitable means.
11. **DO NOT** place the painted parts in water after painting until the paint is fully cured (see recommended times on the label). It is recommended that you prevent paint chips or dust caused by removing paint from entering water.

PRECAUTIONS:

- KEEP OUT OF REACH OF CHILDREN.
- Use only in well ventilated areas.
- When using, do not eat, drink or smoke.
- Wear fresh laundered clothes daily.
- Wash hands and face before eating, drinking, chewing gum, using tobacco or using the toilet.
- Wear chemical resistant gloves, goggles, chemical resistant clothing including hood or hat, long pants, a long-sleeved shirt and shoes plus socks during mixing/loading, application, clean-up and repair.
- Remove clothing/personal protective equipment immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing.
- Wash the outside of gloves before removing.
- Remove personal protective equipment immediately after handling this product. As soon as possible, wash thoroughly and change into clean clothing.

- For cleaning/maintaining personal protective equipment, use detergent and hot water. Keep and wash personal protective equipment separately from other laundry.
- Discard clothing and other absorbent material that have been drenched or heavily contaminated with the product's concentrate. Do not reuse them.

HAZARDOUS DECOMPOSITION PRODUCTS

Carbon monoxide and metal oxides.

ENVIRONMENTAL HAZARDS

Toxic to aquatic organisms. This product contains a petroleum distillate, which is moderately to highly toxic to aquatic organisms: Treated nets should only be used for application where there is infinite water dilution such as open water farming. Not recommended for use in ponds or tanks where copper leached from treated nets may accumulate.

Do not apply directly to water by cleaning of equipment or disposal of wastes. Do not allow chips or dust, generated during paint removal, to enter water.

In addition, prevent spills from entering storm sewers or drains and contact with soil.

FIRST AID

If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for treatment advice.

If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION

This product is not associated with any specific reaction. This product contains petroleum distillates. Vomiting may cause aspiration pneumonia. Treat symptomatically.

STORAGE

Store in original container. Otherwise contact supplier. Do not expose to temperatures below +4°C/+39°F. Do not store for more than 6 months.

DISPOSAL:

1. Triple or pressure-rinse the empty container. Add the rinsings to the treatment site.
2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal.

3. Make the empty container unsuitable for further use.
4. Dispose of the container in accordance with provincial requirements.
5. For information on the disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills.
