If symptoms warrant further treatment, protopam chloride (pralidoxime chloride, 2-PAM chloride) has shown utility as adjunctive therapy. Never use morphine. Continued absorption of the poison may occur, resulting in a fatal relapse after initial improvement; very close supervision of the patient is indicated for at least 48 to 72 hours.
