**DIRECTIONS FOR USE:**

1. Initial Dosage for a freshly-filled pool having no visible algae growth: Add 60 to 80 ml of Tabex Algysolve 2250 per 10,000L of pool water. 2. Initial Dosage for a pool having visible algae growth: Add 150 ml of Tabex Algysolve 2250 per 10,000 L of pool water. Brush pool surface to remove any clinging dead algae. Vacuum pool to waste to remove any dead algae which has settled. 3. Maintenance Dosage of 30 to 50 ml of Tabex Algysolve 2250 per 10,000 L of pool water is to be added weekly, following initial dosage, to keep pool free of algae growth. **DO NOT** contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

**PRECAUTIONS**

KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed. Do not mix with any other chemical. Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Avoid Contact with skin and eyes.

**FIRST AID:**

If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15 – 20 minutes. Call a poison control centre or doctor for treatment advice. If in eyes, hold eye open and rinse slowly and gently with water for 15 - 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

**DISPOSAL:** Rinse container thoroughly before discarding. Do not reuse. For information on the disposal of unused, unwanted product and the clean-up of spills, contact the provincial regulatory agency or the Manufacturer.
