**PRECAUTIONS:**

**FIRST AID:**

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**IF INHALED:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

**DIRECTIONS FOR USE:**

1. Initial dosage for pool water having no visible algae is 100 mL of this product per 10,000 L of pool water.
2. Weekly maintenance dosage is 35 mL of this product per 10,000 L of pool water.
3. For pool water having visible algae, superchlorinate following label instructions of superchlorination product employed and wait at least 24 hours before adding weekly maintenance dosage.
4. For visible algae, when superchlorination is not employed, add 150 mL of this product per 10,000 L of pool water.
