DIRECTIONS FOR USE:

To be used only in the manufacture of a herbicide which is registered under the Pest Control Products Act.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Avoid contact. Wash thoroughly after using or before eating, drinking or smoking. Wear protective clothing including goggles and respirator when handling manufacturing product.

This product contains a petroleum distillate which is moderately to highly toxic to aquatic organisms. Avoid contamination of aquatic systems during application. Do not contaminate these systems through direct application, disposal of waste or cleaning equipment.

FIRST AID:

Note to Physician: If this product is ingested, endotracheal intubation and gastric lavage should be performed as soon as possible, followed by charcoal and sodium sulfate administration. This product contains a petroleum distillate.
