DIRECTIONS FOR USE:

OILFIELD APPLICATIONS:

Use 100 ppm active ingredient until control is achieved. Maintenance dosage 10 – 25ppm. In all applications, cut or tear open the outer bag to expel the SECURE BIO-98B into the system in areas specified below. **IN ALL CASES AVOID SKIN CONTACT. WEAR PROTECTIVE GLOVES.**

PAPER MILLS:

SECURE BIO-98B should be used at 30 – 50 g/tonne of dry paper produced at least once per day.

OIL STORAGE TANKS:

Cut or tear open the outer bag and drop SECURE BIO-98B through thief hatch.

HEAT EXCHANGERS, COOLING TOWERS, CONDENSERS, AIR WASHERS:

Pre-clean heavily fouled systems (e.g. with chlorine). Shock dosages of 100ppm based on the water content of the system may be used until control is achieved. Maintenance dosage 15 – 50ppm. Cut or tear open the outer bag to expel the SECURE BIO-98B directly into the sump of the system at a convenient point.

NOTICE TO USER:

This pest control product is to be used only in accordance with the directions on the label. FIRST-AID:

PRECAUTIONS:

POTENTIAL SKIN SENSITIZER

- KEEP OUT OF REACH OF CHILDREN. DANGER - CORROSIVE TO EYES. Severe eye and skin irritant. Avoid ingestion, inhalation and contact with skin, eyes and clothing. Store away from oxidizing materials, heat or open flame. AVOID CONTAMINATION OF FOOD.
- Wear goggles or face shield, chemical resistant gloves, long pants, a long sleeved shirt, shoes and socks during mixing/loading, clean up and repair.
- Formaldehyde can be released during use of this product.
