# **MIXING INSTRUCTIONS:**

Make sure the spray tank is thoroughly cleaned before mixing. Fill the spray tank half full with water. Add the required amount of herbicide as directed by its label with the agitator running. Ensure that the herbicide is completely mixed before proceeding to the next step. SLOWLY add the ACTIVATE PLUS, agitating during the entire process. Continue to agitate while filling the tank with water and agitate before and during each application to insure a uniform spray.
