For WASPS, HORNETS, and YELLOW JACKETS: Spray directly at stray wasps that enter building, keeping about 1 metre from interior walls, fabrics, and furniture.

#### FOR OUTDOOR USE:

Give special attention to breeding areas, such as around garbage cans. For control of fly eggs, spray around garbage cans from a distance of 40 to 50 cm covering 1 square metre of surface area in 4 to 6 seconds. When spraying be careful that spray does not contact painted surfaces of vehicles. Repeat as necessary.

For CRICKETS, EARWIGS, CENTIPEDES, SOWBUGS, PILLBUGS: Spray around doors, foundations and damp moist places where these insects hide, hitting as many as possible. Repeat spraying as often as necessary.

For ANTS: Spray trails, hills, around doors, openings around pipes, and window frames where ants enter and crawl, hitting as many as possible. Repeat as necessary.
