## **DIRECTIONS FOR USE**

To be used only in the manufacturing of antimicrobial products registered under the *Pest Control Products Act* or products exempt from registration under Schedule II of the *Pest Control Products Act*. Manufacturers are responsible for their own registrations.

## **FIRST AID**

**IF SWALLOWED:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.
