Apply small quantity of lotion evenly to exposed skin surfaces of hands, legs and arms. For face, dispense on palm of hand and spread on face and neck. Avoid contact with eyes and lips. **REAPPLY AFTER 6 HOURS IF NECESSARY.** **PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. Avoid contact with eyes and mouth. Do not use on children under 12 years of age. For external use only. Harmful if swallowed. Avoid contact with plastics and painted surfaces, furniture finishes, acetate and synthetic fabrics. Do not contaminate food, utensils or any body of water. **FIRST AID:** If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If irritation or other adverse effects develop wash with soap and water immediately. Seek medical attention if symptoms persist. If ingested, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
