DIRECTIONS FOR USE: Later's Origins COMPLETE Insect Control Concentrate kills insects on flowers, vegetables, fruit and houseplants. Spray to contact insect eggs, larvae, nymphs and adults. Controls Aphids, Whiteflies, Flea Beetles, Caterpillars, Mealybugs, Thrips, Scale Insects and Spider Mites. Use on houseplants and flowerings plants, such as Roses and Fuchsia, Ornamental Trees and Shrubs, Herbs, Fruit Trees and Vegetables such as celery, tomatoes, peppers, peas, lettuce, potatoes, cucumber and related vine products, radishes, onions, asparagus, beans, squash, cabbage and related plants.

Test sensitive plants (e.g. Ferns) by first applying this spray to a small portion of the plant and wait a few days to see if any damage occurs. The blue sheen of evergreens such as Blue Spruce may be affected by this spray.
