DIRECTIONS FOR USE:

This product contains permethrin and (S)-methoprene. Do not apply another pest control product such as a shampoo, collar, or powder that contains permethrin or (S)-methoprene to the treated animal after applying Hartz[®] UltraGuard Plus[™] Flea & Tick Drops for Dogs and Puppies Weighing up to 14KG (30lbs).

DO NOT USE ON CATS

- 1. Remove one applicator tube from package and hold in an upright position.
