### **PRECAUTIONS**

KEEP OUT OF REACH OF CHILDREN AND PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Corrosive to eyes and skin. Causes severe skin burns. DO NOT get in eyes or on skin. Fatal if swallowed or inhaled. DO NOT breathe sprays. Potential skin sensitizer. Wear goggles or face shield, chemical resistant gloves, long pants, a long-sleeve shirt, and shoes and socks when handling.

- Avoid contamination of food.

Wash thoroughly with soap and water after handling.

### **FIRST AID**

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

**If swallowed,** call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If inhaled,** move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

### **TOXICOLOGICAL INFORMATION:**

There is no specific antidote. Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsion, may be needed.

### **ENVIRONMENTAL PRECAUTIONS:**

This product is toxic to fish. Do not discharge into lakes, streams, ponds, estuaries or public waters. Not for use in marine or estuarine oilfields. Open dumping is prohibited.

### **DIRECTIONS FOR USE**

This product is to be used only in the manufacture of a microbiocide which is registered under the PEST CONTROL PRODUCTS ACT. Formulators are responsible for their own registration under the PEST CONTROL PRODUCTS ACT.

**STORAGE:** Container should be stored in a cool, dry and well-ventilated area. Keep container tightly closed when not in use. Exercise due caution to prevent damage to or leaking from the container. Do not use air pressure to transfer. Do not reuse empty container.

### **DISPOSAL:**

- 1) Triple-or pressure rinse the emptied container. Add the rinsings to the spray mixture.
- 2) Follow provincial instructions for any required additional cleaning of the container prior to its disposal.
- 3) Make the empty container unsuitable for further use.
- 4) Dispose of the container in accordance with provincial requirements.
- 5) For additional information on the disposal of unused, unwanted product, contact the manufacturer of the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of spill, and for clean-up of spills.

**SPILLAGE:** Clean up spills immediately. Larger spills should be flushed to a collection basin for disposal. Clean area well with detergent and water.
