DIRECTIONS FOR USE:

To be used only in the manufacture of a herbicide registered under the *PEST CONTROL PRODUCTS ACT*.

PRECAUTIONS:

FIRST AID:

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

When the technical has been ingested, carry out gastric lavage with care to prevent aspiration. Treatment of intoxication should be symptomatic and supportive.

STORAGE:
