AQUA NOK-OUT Liquid Algaecide is used to control the growth of algae in swimming pools, being effective on green, mustard and other algae. For maximum effectiveness, pools containing heavy growth of algae should be cleaned prior to using AQUA NOK-OUT Liquid Algaecide.

#### **DIRECTIONS FOR USE**

- 1. Initial dosage of AQUA NOK-OUT LIQUID ALGAECIDE for pool water having no visible algae is 200 mL of AQUA NOK-OUT LIQUID ALGAECIDE per 10,000 L of pool water.
- 2. Weekly maintenance dosage is 70 mL per 10,000 L. of pool water.
- 3. For pool water having visible algae, superchlorinate following label instructions of superchlorination product employed and wait for at least 24 hours before adding weekly maintenance dosage.
- 4. For visible algae growth, when superchlorination is not employed, add 300 mL of AQUA NOK-OUT LIQUID ALGAECIDE per 10,000 L of pool water.

#### PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed. Do not mix with any other chemical. Avoid contact with skin and eyes.

## **DISPOSAL**

Rinse container thoroughly before discarding. Do not reuse empty container. Offer for recycling if available, or dispose in accordance with local and provincial regulations.

For information on the disposal of unused, unwanted product and the clean-up of spills, contact the Manufacturer or the Provincial Regulatory Agency. Contact the manufacturer and provincial regulatory agency in case of a spill, and for clean-up of spills.

### FIRST AID

In case of contact with eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**In case of contact with skin or clothing**, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

**If swallowed**, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
