**DIRECTIONS FOR USE**

To be used in the manufacture of a rodenticide which is registered under the PEST CONTROL PRODUCTS ACT.

Avoid breathing dust. Always wash hands after handling bait. Wash hands before eating, drinking, chewing gum, using tobacco or the toilet.

**PROTECTIVE CLOTHING AND EQUIPMENT**

Use chemical workers' goggles, dust mask, and wear clean body-covering clothing.

**FIRST AID**

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention. Get medical attention immediately for any toxic reaction or irritation that persists or is severe.

If in eyes:

Hold eye open and rinse slowly and gently with water for 15-20 minutes.

Remove contact lenses, if present, after the first 5 minutes, then continue rinsing

eye. Call a poison control centre or doctor for treatment advice.

If on skin or clothing:

Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor immediately for treatment advice.

If swallowed:

Call a poison control centre or doctor immediately for treatment advice.

Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If inhaled:

Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

## **TOXICOLOGICAL INFORMATION**

Corn cob fractions are considered a nuisance dust. Treat symptomatically.

## **STORAGE**

Keep in original container during storage. Store in a cool, dry well ventilated place away from seed, feed, fertilizers or other pesticides. Do not contaminate water, food or feed by storage or disposal.
