DIRECTIONS FOR USE:

For ease of application, allow product to warm in room temperature. Insert tube into applicator. Squeeze out and deposit 1 pea-sized or smaller portions of paste every 15-30 cm to cracks and crevices. This product may be applied behind and under stoves, ovens, refrigerators and freezers, dishwashers, sinks and openings around drains and plumbing, pantries, cabinets, cupboards, closets, washing machines and dryers, bedroom dressers and chests or drawers. Any paste visible after application must be scraped into cracks and crevices, or removed. Reapply as necessary. Avoid contamination of feed or foodstuff. Do not apply paste in areas accessible to children and pets. This product may be applied to the following areas:

For use in food areas - limited to crack and crevice treatment only: (Including areas where food and feed is received, stored, prepared, served, packaged and handled and where edible waste is stored): Apply product only when food areas are not in operation. Insert tube into applicator. Apply product according to the DIRECTIONS FOR USE directly into cracks and crevices, where equipment meets the floor and walls; equipment and counter legs, bases, motors and conduits, under booths, tables and chairs; holes and openings leading to wall voids where insects may hide. Cover or remove all food commodities before treatment. Wash all food contact areas with potable water after treatment and before reuse.

NOTE: Food and feed handling and processing establishments include restaurants, dairies, packaging, bottling and canning plants, bakeries, mills or anywhere food and feed is stored, prepared, processed and packaged.

For use in non-food areas: (Including garbage rooms, rest rooms, laboratories, offices, locker rooms, boiler and equipment rooms, garages, mop closets and storage): Apply product according to DIRECTIONS FOR USE around water and drain pipes, underneath and behind sinks, lockers, tables and similar areas where insects may hide.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth if possible. Call a poison control centre or doctor for treatment advice.
