DIRECTIONS FOR USE

To be used in the manufacturing of a pesticide which is registered under the *Pest Control Products Act*. Formulators of pesticides are responsible for obtaining their own registrations for each of their pesticide products.

FIRST AID

IF SWALLOWED:	Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.
IF ON SKIN OR CLOTHING:	Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.
IF IN EYES:	Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.
IF INHALED:	Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Harmful if inhaled. Avoid inhaling/breathing dust. Causes eye irritation. Avoid contact with skin, eyes or clothing and avoid breathing dust. Wear protective eyewear (goggles or face shield). Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before re-use. Use with adequate ventilation. Do not smoke, drink, or eat when handling. Do not ship with food, feeds, drugs, or clothing. Keep container tightly closed when not in use.

ENVIRONMENTAL HAZARDS:

Keep out of lakes, streams, or ponds. Do not contaminate water by cleaning of equipment, or disposal of wastes. Do not discharge into lakes, streams, ponds, or public water. Use this product only as specified on this label.

CHEMICAL AND PHYSICAL HAZARDS: Will decompose on sublimation above 452°C (845°F), releasing toxic gases. Avoid comminution and dusting.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Store in a cool, dry, well-ventilated area, in well-closed original containers, away from energy sources, strong oxidizers, acids, alkaline, and heavy metal salts. Avoid exposure to moisture. Pesticide wastes are acutely hazardous.

DISPOSAL

Canadian manufacturers should dispose of unwanted active ingredients and containers in accordance with municipal or provincial regulations. For additional details and clean up of spills, contact the manufacturer or the provincial regulatory agency.

SPILLS

When handling or dealing with spills, use impact resistant goggles with side-shields or face shield; body-covering clothes, including impervious rubber or plastic gloves and boots. Avoid raising dust; use a dust respirator if dusting occurs. Sweep up dry spills and dispose of as described for DISPOSAL.
