PRECAUTIONS

Danger – eye irritant. Avoid contact with eyes. Workers should wash hands before eating, drinking, chewing gum, using tobacco or the toilet.

PROTECTIVE CLOTHING AND EQUIPMENT

Use chemical workers' goggles and wear clean body covering clothing.

FIRST AID

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

TOXICOLOGICAL INFORMATION

No specific antidote. Employ supportive care. Treatment should be based on judgment of the physician in response to reactions of the patient.

AGRICULTURAL CHEMICAL

Do not ship or store with food, feeds, drugs or clothing.

ENVIRONMENTAL HAZARDS

Do not contaminate any body of water by direct application, cleaning of equipment or disposal of wastes. **TOXIC** to non-target terrestrial plants. **TOXIC** to aquatic organisms.

STORAGE

Keep in original container during storage. Store in a cool, dry well ventilated place away from seed, feed, fertilizers or other pesticides. Do not contaminate water, food or feed by storage or disposal. Keep away from fire or open flame, or other source of heat.

DECONTAMINATION AND DISPOSAL

In case of spill or leak, shovel or sweep up material and any contaminated ground and place in a plastic-lined metal drum. Canadian manufacturers should dispose of unwanted active ingredients and containers in accordance with municipal or provincial regulations.
