DIRECTIONS FOR USE: This product is for use against aggressive dogs only. Depress top button, spraying into face and eyes of threatening dog. Spray in a series of short bursts. Spray is most effective at short range (up to 3m).

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Severe irritation to eyes, nose, respiratory and skin areas can occur. Avoid contact with skin and eyes and inhalation of spray. Contents under pressure. Use outside only. Persons with respiratory problems or wearing contact lenses should not use this product. Do not place in hot water or near radiators, stoves or other sources of heat.
