DIRECTIONS FOR USE: To be used only in the manufacture of a product which is registered under the *PEST CONTROL PRODUCTS ACT*.

PRECAUTIONS: PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

FIRST AID:

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.
