DIRECTIONS FOR USE: Read all label directions before using.

Wilson® WeedOut® Granular Herbicide controls many annual grass and broadleaf weeds as they germinate. This product does not control established weeds. It must be applied to freshly weeded soil before weeds germinate. The treatment must reach the zone of weed seed germination. If rainfall does not occur within 7 days for a spring or fall application or 2 days for a summer application (June, July and August), a shallow incorporation to a depth of 2.5 to 5 cm or a watering with sufficient water to wet the soil to a depth of 5 to 10 cm is necessary.

AREAS OF USE - Ornamental Plantings, Ground Covers, Shrubs, Fruit and Nut Trees

Apply over small established ornamental plants or around larger plants in flower beds, container plantings, ornamental landscapes and ground covers, fruit trees, nut trees or potted ornamentals grown for aesthetic purposes. Do not use where plants are seeded.

APPLICATION RATES: For control of the listed weeds, apply 23 grams of this product per square meter (this 500g package per 22 square metres). Spread evenly on the soil surface using the shaker can. Do not apply when weather conditions favour drift from intended treatment area.

PRECAUTIONS: May be harmful if swallowed. Avoid contact with skin, eyes and clothing. Wash thoroughly after use. Avoid contamination of seed, fertilizer, food and feed.

If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

ENVIRONMENTAL HAZARDS: Keep out of lakes, streams and ponds. Do not contaminate any body of water, including irrigation water or water used for domestic purposes. Do not contaminate water by cleaning of equipment or disposal of wastes. This product contains a petroleum distillate which is moderately to highly toxic to aquatic organisms.
