PRODUCT DESCRIPTION

Pt-PFC2139 is a wettable powder containing the active ingredient, viable mycelium of *Chondrostereum purpureum* PFC2139. *Pt-PFC2139* is used only as a technical in formulation of the biological herbicide Lalcide Chondro, which is registered under the PEST CONTROL PRODUCTS ACT for the inhibition of resprouting and regrowth from cutstumps of red alder and Sitka alder in rights-of-way and forest vegetation management.

DIRECTIONS FOR USE

To be used only in the manufacturing or formulating of Lalcide Chondro which is registered under the PEST CONTROL PRODUCTS ACT for the inhibition of resprouting and regrowth from cut stumps of red alder and Sitka alder in rights-of-way and forest vegetation management.

DO NOT contaminate water by cleaning equipment or disposing of equipment washwaters.

PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. May cause sensitization. May irritate eyes. Avoid contact with eyes, skin or clothing. Avoid inhaling dusts. Wear a long-sleeved shirt, long pants, protective eyewear (goggles), waterproof gloves, socks and shoes, and NIOSH-approved respirator with any N, R, or P filter for biological products when handling the product and during all clean-up/repair activities. FIRST AID
