DIRECTIONS 'HOT WUG: For the control of wasps, bees, hornets and yellow jackets, remove protective cap and point nozzle in direction of the wasp nest or at the insect. Press the nozzle and completely saturate the nest from a distance of 2 to 2.5 metres. Allow sufficient time for insects to die. Application to wasp nests should be made in late evening or early morning when insects are at rest.

LIMITATIONS: Do not use inside homes, on humans or animals. Do not use as a space spray.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. May be harmful if swallowed, inhaled or absorbed through skin. Provide adequate ventilation of area being treated.
