FOR USE ON CRAWLING INSECTS such as ants, centipedes, cockroaches, crickets, fleas, silverfish, earwigs and spiders.

DIRECTIONS: Shake well before using. Hold container upright while spraying. Contact as many insects as possible with the spray in addition to thorough spraying of all parts of the room suspected of harboring these pests. Special attention should be paid to cracks, hidden surfaces under sinks, behind stoves and refrigerators, storage areas and wherever these pests are suspected of hiding. To kill ants, treat doors, around window frames, ant trails and other areas of entry. Repeat as required. **FLEAS:** Spray animal sleeping quarters and floors around area, but not furniture or carpets that people regularly contact. For other insects listed above spray around doorframes and window frames both indoors and outdoors.
