FIRST AID

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If Inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Directions for Use

To install or replace the NoSquito™ Lure into the Stinger® Outdoor Insect Killer Device:

- 1) Peel foil cover and snap (hole side down) into the built-in-holder at the bottom of the Stinger Outdoor Insect Killer device
- 2) For other bug zappers or mosquito traps, place the lure in the small cassette provided and attached to the other enclosure
- 3) For best results, replace lure after 14 days.

STORAGE AND DISPOSAL:

Octenol Lure Storage: Store in original container in a cool, dry area and out of reach of children until ready to use.

Octenol Lure Disposal: DO NOT reuse spent lures. Dispose in household garbage. Unused or partially used products should be disposed at provincially or municipally designated hazardous waste disposal sites.
