Corrosive. Causes irreversible eye and skin damage. Causes skin burns. Harmful or fatal if swallowed. Harmful if inhaled. Harmful if absorbed through skin. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals. Causes asthmatic signs and symptoms in some hyper-reactive individuals. FIRST AID

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

STORAGE

MC B-8725 is corrosive to many commonly used materials of construction such as steel, galvanised iron, aluminium, tin and zinc. These solutions can be stored and handled in baked phenolic lined steel, polyethylene, stainless steel or reinforced epoxy equipment. This product freezes at approximately -10°C. Therefore, unless the storage tank is inside or underground, heating and insulation may be required. If heating is needed, exposure to high temperatures should be avoided. For short storage (1 month) temperatures up to 38°C (100°F) can be tolerated; however, the preferred maximum storage temperature is approximately 27°C (80°F). Keep away from fire and open flames. A stainless steel centrifugal pump is suggested for transfer service. To prevent contamination store this product away from food or feed.

SPILLAGE

Absorb onto sand, earth or inert mineral. Sweep up and remove the spillage to a polythene lined container for subsequent correct disposal. Clean the area with detergent and water.

DIRECTIONS FOR USE

DO NOT open pour more than 20 L of concentrate per day. Use an automatic addition system if using more than 20 L of concentrate per day. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes. DO NOT discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters.

OIL WELL DRILLING, OIL FIELD PROCESS APPLICATIONS, GAS PRODUCTION AND TRANSMISSION SYSTEMS

WATER FLOODS

MC B-8725 should be added to a water flood system at a point of uniform mixing.

Initial Treatment: When the system is noticeably contaminated, add 200 – 10,000 ppm MC B-8725 to the system (0.20 litres to 10 litres of MC B-8725 per 1000 litres flood water). Repeat until control is achieved.

Subsequent Dose: When microbial control is evident, add 40 – 10,000 ppm MC B-8725 (0.04 litres to 10 litres of MC B-8725 per 1000 litres flood water) to the system weekly or as needed to maintain control.

GAS PRODUCTION AND TRANSMISSION PIPELINES AND SYSTEMS

MC B-8725 should be added to a gas production or transmission line via direct injection. The application should be conducted to ensure maximum distribution of MC B-8725 through the entire internal surface of the pipeline. To facilitate application it may be desirable to dilute the MC B-8725 with the appropriate solvent immediately before use. Injections to the system should be made on a weekly basis, or as needed to maintain control.

GAS STORAGE WELLS AND SYSTEMS

Individual injection wells should be treated with sufficient quantity of MC B-8725 to produce a concentration of 1000 to 10,000 ppm MC B-8725 when diluted by the water present in the formation. Injection should take place before gas is injected (during the summer). Injections should be repeated yearly, or as needed to maintain control. Individual drips should be treated with a sufficient quantity of MC B-8725 to produce a concentration of 400 to 4000 ppm MC B-8725 when diluted by the water present in the drip. Injections should be repeated yearly, or as needed to maintain control.
