DIRECTIONS

Repels mosquitoes for 3 hours. Also repels black flies, biting midges, deer flies, stable flies, ticks and chiggers. Apply sparingly not under clothing and only when necessary. Reapply after 3 hours if necessary. Hold container upright and spray clothing and exposed skin, except face. TO APPLY TO FACE: Spray hands and apply avoiding eyes and mouth. Do not spray in enclosed spaces.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN. CONTENTS UNDER PRESSURE. Do not place in hot water or near radiators, stoves or other sources of heat. Do not puncture or incinerate container or store at temperatures over 50°C. Do not spray near open flame or spark, or while smoking. Do not contaminate food, utensils or any body of water.
